Foundation Apprenticeship Programme Level 3 Assistant Accountant



The Network's Foundation Apprenticeship is a programme aimed at school and college leavers supporting health service employers to develop the workforce of the future.

The 18-month Level 3 Assistant Accountant Apprenticeship is intended for individuals commencing roles within a Finance function; typical job roles include Purchase/Sales Ledger Clerk, Finance Assistant etc.

What the Programme Includes:

Recruitment

- Attraction, screening and assessment of potential apprentices
- Upfront employability skills training
- Work experience placement
- Employment via a lead employer

Development

- Induction
- Day release, classroom training in Liverpool or Manchester
- Online learning materials
- Coaching
- Development Days
- Student Conference
- AAT membership

Support

- Regular meetings in the workplace with a Training Adviser/Coach

What the Learning Involves:

On programme apprentices will be provided with training on the following AAT units:

- Bookkeeping Transactions
- Bookkeeping Controls
- Advanced Bookkeeping
- Final Accounts Preparation
- Indirect Tax
- Management Accounting: Costing

As well as classroom learning apprentices will be expected to undertake independent study in order to adequately prepare them for the exam at the end of each unit.

What End Point Assessment (EPA) Entails:

The purpose of the EPA is to assess an apprentice's competency in the role.

Apprentices are put forward for EPA when they have:

- Passed the AAT unit exams
- Completed at least 20% 'off the job' training
- Produced a portfolio of work based evidence

The EPA consists of the following components:

- Synoptic exam
- Professional discussion with an independent assessor in relation to the portfolio of evidence and work experience gained

On completion a final grade of either Pass or Distinction is awarded to recognise achievement.

In addition to the L3 Assistant Accountant Apprenticeship individuals who successfully complete the programme will also gain the AAT L2 Certificate in Bookkeeping and L3 Advanced Diploma in Accounting.

Programme Duration & Costs

- The programmes takes 18 months to complete during which time apprentices are employed by a lead employer on a fixed term contract
- Apprentices are paid National Minimum Wage ie. £4.81 hr or £9,406 pa for under 18s (figures correct as at 1st April 2022)
- Apprentices have to be enrolled as student members of AAT whilst on programme at a cost of £134 plus VAT per year; these fees cannot be paid from the apprenticeship levy
- The cost of training, paid via the levy, is £8,000.

Progression

On completion apprentices could progress on to the L4 Professional Accounting Apprenticeship and ultimately the L7 Accountancy Professional Apprenticeship incorporating professional qualifications.
