# Heads up Faster Reporting 1

Driver for changing the timetable:

- Increased pressure internally and externally to provide the financial position sooner.
- Benefits the organisations One NHS Finance Working Day 1:

  - putting the organisation on the front foot, creating a rhythm about the financial management cycle.....work earlier with operational teams to influence service and financial performance.....concerns have been raised about accuracy.....implemented successfully....trust in the finance teams' judgment has been empowering.

# **Heads up Faster Reporting 2**

  - 'What is the function of a budget report?' says the Leeds finance director. 'It is not to be a forensically accurate bank statement, down to the last penny. It is there to highlight if there are any material issues that management needs to take action on. And in that context, it is better to get it out quickly.'
  - o it does not mean doing seven days' work in a single 24 hours. In fact, it is not about producing reports faster. Instead, it involves shifting activities to the left on the timeline.
  - 'We thought we'd probably be working with about 80%-90% accuracy of our transactions,' says Portsmouth's assistant director of finance Steve Smith. 'In reality, we are much more accurate than that and I think we are 99% of where we were at before working day 1.

# **Heads up Faster Reporting 3**

Our current proposal is:

Reduce by 2 days from month 2 reporting 2025 – the start of 2025/26 reporting.

Reduce by a further 2 days from May 2026, the start of 2026/27. This would mean systems reporting to NHS
England on WD6. This move would be dependent on the ICB / ISFE2 deadline being brought forward, the
current ledger close is WD7, this is key to achieving earlier system / ICB reporting.

### **Questionnaire Feedback**

- Still reviewing 230 responses. Generally supportive of the 1<sup>st</sup> 2 day reduction, generally not supportive of the 2<sup>nd</sup> 2 day reduction. 50/50 split on whether to change from M2 or later in year.
- National propose to enact all their internal changes in time for M2 ie. webinar, forms etc done 2 days earlier, with formal submissions not changing until M6. This will enable those who want to, to trial moving earlier before the formal change is required.
- Final shift in M6 is dependent on ISFE2, as want to avoid a clash of ISFE2 and faster reporting happening in same month.
- Latest intel (unconfirmed) suggests ISFE2 may be M6 and therefore the 1<sup>st</sup> 2 day reduction may be pushed back further.
